In addition, USDA Rural Development requires that <u>"net family assets" (that amount remaining after loan closing) along with a cumulative total \$5,000 or greater be considered in the "annual income" calculation.</u> The greater of the actual income derived from <u>ALL</u> net family assets or a percentage of the value of such assets based on the current passbook savings rate must be considered when calculating annual income for eligibility purposes.
